The Comptroller General of the United States is the leader of the GAO, and is appointed to a 15-year term by the U. S. President. The GAO wants to support Congress, while at the same time doing right by the citizens of the United States. They audit, investigate, perform analyses, issue legal decisions and report anything that the government is doing. This is one of their reports. GAO found that the projects include certain factors that may detract from a successful demonstration because: (1) demonstration results will not provide statistically valid estimates for all the SSA disability programs; (2) states are not consistently implementing the projects; (3) the use of the demonstration control group involving the continuing disability review process may not be appropriate or may be potentially misleading; and (4) evaluating claimant satisfaction will be difficult.
